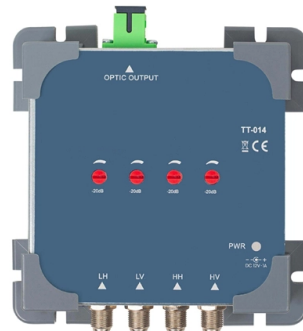

You must complete the export declaration in advance, before your parcel reaches customs. You can submit the declaration yourself on the Finnish Customs website using your bank codes and personal
