

## Luxembourg Customs Declaration 100G Pluggable Optical Module



### Overview

Customs declaration procedures are detailed on the Guichet.lu website: 1. import declaration to Luxembourg 2. export declaration from Luxembourg. The form and content of customs declarations must comply with the Union Customs Code. All customs declarations must: 1. be established using the Single Administrative Document (SAD), a format that is used to harmonize and standardize customs data 2. include all data specified by a European regulation, according to the nature of the customs declaration. To secure the international supply chain, concerned operators must file pre-arrival/pre-departure declarations. The Customs Administration carries out a computerized risk analysis based on the data thus received. Goods deemed at risk are subject to customs control for safety and security purposes upon their arrival or prior to their departure. At en. Customs declarations and pre-arrival/departure declarations must be provided to the Customs and Excise Administration. The person who must declare the goods to customs is the declarant. This is usually the owner of the goods. The declarant may choose to be represented to customs by a customs representative. The customs representative files the cust.
